- The NCRG asks for your WIA membership status in order to calculate the annual cost of insurance. The NCRG is required to pay for non-WIA members. This information does not have to be provided.
- The NCRG does publish a membership listing for all members from time to time. You agree that provided information in this form may be made available to other members in such a membership list, unless you specifically advise the president, secretary or treasurer of the NCRG otherwise.

OTHER INFORMATION

- If your application is accepted you are entitled to inspect and make a copy of the register of members under section 27 of the Associations Incorporation Act.
- If your application is accepted you are entitled to inspect and make a copy of the rules (constitution) of the association under section 28 of the Associations Incorporation Act.
- If your application for membership is rejected by the members under rule 4(b), you may give notice of your intention to appeal within 14 days of being advised of the rejection. The Association, in a general meeting, no later than the next annual general meeting, must give you a reasonable opportunity to be heard or to make written representations to the Association.
